1. Authority to Operate

ccCNA is a Utah approved nurse aide program by Utah Nursing Assistant Registry 550 East 300 South Kaysville, Utah 84037 801.547.9947. ccCNA is exempt from REGISTRATION UNDER THE UTAH POSTSECONDARY PROPRIETARY SCHOOL ACT (Title 13, Chapter 34, Utah Code). The institution is not accredited by a regional or national accrediting agency recognized by the United States Department of Education.

2. Our Facility

ccCNA classroom is fully equipped with hospital beds, IV poles, mannequins, desks, chairs, multi media projection equipment, built in sound system, wheelchairs, catheter bags, crutches, walkers, bedside commodes and the equipment and supplies needed for hands on learning.

3. Owners and Instructors

Carol Lindsay, owner has been a Registered Nurse for 20+ years. Carol has taught CNA classes for 20+ years. She has worked in long term care, pediatrics, emergency, and labor & delivery. She holds a BSN in Nursing and a Masters in Management and a Masters in Nursing Education from the University of Wyoming. In addition to teaching Carol has been published in NurseWeek, Nursing Spectrum, American Journal of Nursing, Journal of Emergency Nursing and Nursing and the Salt Lake Tribune.

Claudia Wilcox, owner has been a Registered Nurse for 30+ years. Claudia has taught CNA classes for 15+ years. She has worked as a Registered Nurse in long term care, emergency, pediatrics, home care, cardiology, endoscopy and OR.

4. Courses Offered

ccCNA offers an **100 hour training** course that prepares students to apply for and complete the state testing allowing them to be certified by the state of Utah as certified nurse aides and be placed on the state registry. At completion of the class students who pass our test and complete clinical hours will be placed on the state "completer" list and be given an application stating they have completed the requirements set by the state to take the state nurse aide certification test. Classes run throughout the year on a biweekly or monthly basis.

5. Cost

Total costs and payment plans for each program, including application, registration fees, tuition, books, supplies, equipment, laboratory, special tutoring, late payment, and graduation fees. There are no payment plans. Full tuition to be paid on the first day of class. Total cost for the C.N.A. class is \$450. There are no loans, no installment plans and no interest.

6. Admission Requirements

Student admission and enrollment requirements is 16. There is no granting of prior credit such as reduced hours in the program or any tuition discount for any previous education or training completed. Students in the nurse aide course must attend all 80 hours of nurse aide class and 6 hours of phlebotomy to complete the classes. Classes may be made up within a 6 month period at no additional charge. To pass the C.N.A. class and qualify to take the state test student must pass a final exam with 83% (125/150 test questions) Those who do not pass the C.N.A class may retake the class at no additional charge up to three times in a 6 month period after the original class is completed.

Students who practice inappropriate behavior in the classroom or clinical setting will be expelled from the program. This includes: drugs, alcohol, and inappropriate verbal or physical behavior with residents. Students will dress in a professional manner for their clinical experience. No one with a felony conviction or who is listed on a sex offender registry will be admitted to class.

Clean, neat scrubs will be worn to clinical. Clean shoes. No facial jewelry. One pair of earrings only. Hair tied back away from face. No extra jewelry. No visible tattoos. No underwear, thong or otherwise to be visible at any time.

7. Job Placement

Assistance with job placement is available through our clinical sites. Students who request assistance finding Jobs in long term care facilities are assisted in filling out applications and arranging interviews. Our clinical sites offer employment opportunities for the majority of our staff.

8. Refund Policy

The refund policy for both withdrawn and dismissed students is the same. The \$450 fee is refundable until after completion of the first day of class. The fee can be applied to a class at a later date.

9. Graduation and Employment Rates

Pass rates for the Utah State Certified Nurse exam for 2010 are cumulative 96% for written test and 97% for skills test. (This is +7 and +7 percent higher than state average). A survey of 2010 students showed that 22% of graduates were employed as C.N.A's. Note: Many of our students take the class as a prerequisite for nursing school and do not seek work as aides.
